- **SPEECH:** A three (3) minute memorized speech will be required. A speech longer than 3 minutes will result in point reduction. The topic is TEXAS FAIR & RODEO (Be original). This will take place at TBD.
- **PERSONAL INTERVIEWS:** The judges will interview each contestant after speech on Saturday.
- Personal Presentation: You will model one outfit only. Contestants must dress in full. Rodeo attire for all aspects of the contest. Long Sleeve Shirt, Cowboy Hat, vests, or jackets should be worn for personal presentations. NO DRESSES ARE ALLOWED for any part of the contest.

**APPEARANCE:** Accumulative score throughout the contes.
